The Franklin B. Walter All-Scholastic Award was established in 1989 by Ohio's County Superintendents to recognize outstanding student achievement. One senior from each of Ohio's eighty-eight counties is chosen to receive this annual honor. The recipients we recognize today are some of the best and brightest students in the Class of 2012.

The F.B. Walter Award is named after Dr. Franklin B. Walter, who served as State Superintendent from 1977-1991.

The Medina County Schools' ESC Virtual Learning Academy will be offering Summer School and Credit Recovery/Enrichment Options for Medina County area junior and senior high school students. The online curriculum is provided by Aurora Learning, a leader in Internet courses of study. The structure of online lessons provides students with challenging assignments, regular reviews and discussion with their teachers, and immediate feedback. With computerized instruction, students advance at their own pace and they never feel pressured to rush through an assignment. High school and junior high school courses are available. Lessons require students to read and demonstrate their ability to analyze, think, and articulate their thoughts.
