### INDEPENDENT CONTRACT SERVICES AGREEMENT OCCUPATIONAL AND SPEECH THERAPY - ESY 2023

#### BETWEEN

#### MEDINA EDUCATIONAL SERVICE CENTER

#### AND

### ABC THERAPY, LTD (admin@abctherapyltd.com)

This agreement is entered into in Medina, Ohio, by and between the MEDINA EDUCATIONAL SERVICE CENTER ("Program") and ABC THERAPY, LTD. ("ABCT"), pursuant to action duly adopted by the Program on April 3, 2023.

WHEREAS, ABCT has been notified and acknowledges that no promises or assurances of ongoing contractual occupational therapy services have been made to ABCT or its employees by the Program; and

WHEREAS, the position of administering occupational therapy services requires short-term, unsupervised work requiring the exercise of discretion, judgment and technical expertise by ABCT and its employees, and, as such, ABCT and its employees acknowledges that this is a contract for independent services and is not a regular or permanent, part-time or full-time employment position with the Program; and

WHEREAS, ABCT and its employees also acknowledges that this position does not entitle ABCT or its employees to any fringe benefits, sick leave or paid vacation, or retirement, and that taxes will not be withheld and will be the responsibility of ABCT;

NOW, THEREFORE, IT IS MUTUALLY AGREED, as of the signed date of this Agreement as set forth below, ABCT is to provide services in the capacity of occupational therapist and occupational therapy assistant; and that the Program hereby contracts with ABCT and its employees to serve these positions. As the occupational therapy service provider, ABCT and its employees shall provide occupational therapy services to students of the Program within the summer school environment for the ESY 2023 term.

1. <u>Term.</u> The term of this Agreement shall commence on May 1, 2023 and shall remain in force for a period of three (3) calendar months, ending on August 4, 2023.

2. Services. Services provided by ABCT and its employees for the Program will be for the provision of occupational therapy services for the summer term, ESY 2023 with hours of service to be determined based on the total number of students to receive occupational therapy services during the Summer Enrichment Program; minimal Program days per week to be two. Services are to include program planning/team meeting time attendance, direct student services, team collaboration, session service documentation, data collection and progress reporting, and therapist/assistant supervision time as applicable.

ABCT and its employees will be responsible for maintaining and providing copies to the Program of all the records of intervention and other procedures, programs established, and written progress reports. ABCT and its employees agree to comply with all FERPA and HIPAA regulations related to the provision of occupational therapy services for the Program.

ABCT and its employees agree that all occupational therapy services provided shall be rendered in an ethical and proper manner and employees of ABCT shall be duly licensed to practice as an Occupational Therapist or an Occupational Therapy Assistant in the State of Ohio.

3. <u>Compensation</u>. The Program shall compensate ABCT at the rate of fifty dollars (\$50.00) per hour for all occupational therapy services provided, inclusive of travel time to and from the school(s) and/or other sites deemed necessary for the provision of occupational therapy services, and for meeting and/or other service provision in addition to the regularly scheduled days of service.

The Program agrees to reimburse ABCT for services provided within fourteen (14) calendar days from the date an invoice is received from ABCT for services delivered each month for the term of the contract.

- 4. <u>Insurance</u>. ABCT and its employees shall have malpractice insurance in an amount sufficient to cover occupational therapy services hereunder. It is further agreed that ABCT and its employees shall be held harmless from acts of employees of schools. ABCT agrees that the provision of workers' compensation coverage; for declaring earnings for all tax purposes (local, state and federal); and for paying all public retirement of social security contributions for the occupational therapy services is the sole and exclusive responsibility of ABCT.
- 5. <u>Facilities</u>. The Program shall provide ABCT and its employees without any charge whatsoever, such as floor space, equipment and supplies, utilities, and maintenance in its facility as it shall reasonably determine to enable said therapist to perform services and responsibilities hereunder.
- 6. Equipment. The designated therapist from ABCT in performance of responsibilities may utilize all therapy equipment presently available hereunder.

7. <u>Notices</u>. Any notice or other communication required or desired to be given hereunder shall be deemed sufficiently given when delivered personally or mailed by first class or certified mail, given or addressed as follows:

8. Governing Law. This agreement is made and may be performed in part in Ohio, and the various terms, provisions, covenants and agreements, and the performance thereof, shall be construed, enforced and determined under and with reference to the laws of the state of Ohio. If any one or more covenants, agreements, terms and provisions herein contained shall be held contrary to the policy or express law, or against public policy, or shall for any reason whatsoever be held invalid or unenforceable, then such covenants, agreements, terms and provisions shall be deemed separable from the remaining covenants, agreements, terms and provisions of this Agreement and such holding shall in no way affect the validity or enforceability of any of the other covenants, agreements, terms and provisions hereof.

- 9. Non-Hire. The parties agree that upon termination of this agreement, whether by the Program or ABCT, and irrespective of the mode or cause of termination, the Program will not, for a period of twenty four (24) calendar months from the date of such termination contract for services with any employee or former employee of ABCT or its affiliated companies.
- 10. <u>Non-Discrimination</u>. Both the Program and ABCT will not discriminate in the provision of therapy services under their authority to an eligible individual and shall ensure nondiscrimination in employment, access to facilities, programs and activities on the basis of race, color, age, gender, creed, disability, or national origin.
- 11. <u>Miscellaneous</u>. This Agreement constitutes the entire understanding of the parties hereto with respect to the subject matter hereof, and may not be modified, changed, or amended except in writing signed by each of the parties hereto. This Agreement may be signed in duplicate, each of which shall be deemed and original hereof. The captions of the several sections and subsections of the Agreement are not a part of the contest hereof, are inserted only for convenience in locating such sections and subsections, and shall be ignored in construing this Agreement.

#### Memorandum of Understanding (MoU)

This Memorandum of Understanding (MoU) for the provision of leasing facility space is entered into on this 1st day of July, 2023 ("Effective Date") between the Northeast Ohio Network for Educational Technology (a program of the Metropolitan Regional Service Council) ("NEOnet") and the Medina Educational Service Center ("ESC").

WHEREAS, NEOnet is an information technology center ("NEONET") organized as a regional council of governments and operating as part of the Ohio Education Computer Network ("OECN"), which has been established by the State of Ohio to provide internet, network, and application services and support to public schools and other authorized user entities; and

WHEREAS, NEOnet requires additional space for office and professional development training purposes, and the ESC has available space to sublet; and

WHEREAS, NEOnet and the ESC desire to enter into an agreement to establish the terms and conditions governing the subletting of space and the provision of services;

NOW, THEREFORE, NEOnet and the ESC agree as follows:

#### I. PURPOSE:

The purpose of this Agreement is to outline the terms and conditions under which NEOnet agrees to provide technical support services in exchange for use of office and meeting spaces.

#### II. PREMISES

- A. The ESC agrees to provide one furnished lockable office and access to the professional development space on the 1st floor of the Board Office, located at 275 Center Street Seville, OH 44273 (Exhibit A).
- B. In addition to the area leased to NEOnet described above, NEOnet shall have reasonable access to the following areas of the building: public restrooms; lounge; halls; vestibule; janitorial and mechanical; any public parking area appurtenant to the building.
- C. NEOnet shall have the right to use the sublet space solely for the purposes stated in this MoU.

#### III. SERVICES PROVIDED / RENT

- A. NEONET shall provide the following services to ESC in exchange for the subletting of space:
  - Technical Support Services with a valuation of \$30,000

#### IV. TERM AND TERMINATION

- A. The sublet space shall be made available to NEOnet commencing from the Effective Date, and terminating on June 30, 2024.
- B. The service agreement will automatically renew for a period of one (1) year, unless either party provides a notice of termination ninety (90) days prior to the expiration date.
- C. In the event of termination, NEOnet shall vacate the sublet space within 10 days and return it to the ESC in the same condition as received, subject to reasonable wear and tear.

#### V. CONFIDENTIALITY

Both parties shall maintain the confidentiality of any proprietary or confidential information obtained during the

term of this MoU.

B. Confidential information shall not be disclosed to any third party without the prior written consent of the disclosing party, except as required by law.

#### VI. GOVERNING LAW AND DISPUTE RESOLUTION

- A. This MoU shall be governed by and construed in accordance with the laws of the State of Ohio.
- B. Any disputes arising out of or relating to this agreement shall be resolved amicably through good-faith negotiations between the parties.
- C. If a resolution cannot be reached through negotiations, the dispute shall be referred to mediation or arbitration in accordance with the rules and procedures agreed upon by both parties.

#### VII. NOTICES

A. All notices permitted or required to be given to either of the parties to this MoU shall be in writing and shall be deemed given or delivered when: (a) emailed with confirmed receipt (b) delivered by hand or (c) mailed, if sent by regular mail or other express delivery service (receipt requested), in each case to the appropriate addresses set forth below (or to such other addresses as the party may designate by notice to the other party hereto):

A. If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

#### IX. AMENDMENTS:

Any modifications or amendments to this Agreement shall be made in writing and signed by both Parties.

#### X. ENTIRE AGREEMENT:

A. This MoU constitutes the entire agreement between NEONET and ESC, superseding any prior agreements or understandings, whether written or oral, relating to the subject matter herein.

By signing below, the signatory certifies authorization to sign on behalf of the ESC and NEOnet and certifies having read, understood and agreed to the terms of this MoU. Signatory certifies that all information provided by ESC and NEOnet in connection with this MoU is true and accurate.
