EDUCATION AGENCY RELATIONS GOALS

The Board will cooperate with other school districts and with other local, State and regional agencies and organizations in the solution of educational problems of common concern. This cooperation may extend to such areas as research, exchange of information and data, coordination of curriculum, coordination of school calendars and activities and construction of facilities, which might be efficiently used on a cooperative basis. Other activities, which may be advantageous to serve a broader area than one district, may also be considered.

In carrying out this policy, the Superintendent may include in his/her recommendations to the Board an evaluation of the desirability and feasibility of cooperation with other agencies in endeavors, which could benefit the ESC and its member districts.

RELATIONS WITH OTHER SCHOOLS AND EDUCATIONAL INSTITUTIONS

It is the policy of the ESC Board that lines of communication be maintained by this ESC with other districts and institutions, which provide program, training or services not available to children residing in this county and with local districts whose resident students are enrolled for programs in this ESC.

The Board directs the ESC to enter into such cooperative ventures with institutions of higher learning or private nonprofit corporations or associations organized for the purpose of providing instruction to the students of this county. The Board also authorizes the Superintendent to negotiate with special care institutions that may be able to offer special services to students, but this Board must first ratify any such agreement.

SELECTING INTERNS

The Board encourages cooperation with State-approved colleges and universities in the training of interns.

Colleges and universities should first make contact with the Superintendent regarding placement of an intern.

The Superintendent makes the final placement of interns.

Staff members who agree to serve as supervisors of the interns may accept honoraria or stipends directly from the college/university for those services rendered outside the regular school day and above and beyond the duties and responsibilities specified in their contracts.

The following conditions shall also be met:

- 1. The institution making the assignment shall provide on-going supervision in a manner suitable to the Superintendent.
- 2. If at any time the quality of the internship is judges to be inferior or he/she is disruptive to the on-going program, the Superintendent may request withdrawal of that person from the program.

The Superintendent may terminate this program if one or more aspects of the program are not of high quality or meeting ESC needs or expectations.
