A Safe Sitter® Essentials babysitting class was held on July 29, 2017. There were 15 students in attendance. The following topics in the updated curriculum were covered: 1) safety skills, 2) childcare skills, 3) first aid and rescue skills, and 4) life and business skills. Each participant received a Safe Sitter® patch for completion of the course.
